Student Pick Up

Student pick up will be done by the door at the end of the Kindergarten hallway. Looking at the school, this is the door at the far right end of the building. Please park in the loop and walk up the sidewalk. In order to pick up the student, one must state the confidential code word (written below) on the walkie. This code word should only be shared with those that are permitted to pick up the student.

Agreement:

I have read and understand the Chastain Road Elementary Colts Camp--After School Program Information provided to me.

I understand:

- Colts Camp begins the first day of school and operates on all days that school is in session for students. If the district has an Early Release Day or there is inclement weather, there is no After School.
- **Tuition payments are expected on Monday of each week. If you have not paid full weekly tuition by Wednesday of each week, a \$10 late fee will be applied. The full weekly tuition and added late fee will then be due by Friday of that week.**
- **If full weekly tuition has not been paid by Friday afternoon (when you come to pick up your child) of each week, your child may no longer attend Colts Camp until tuition is paid in full.**
- Payment for the week of Thanksgiving Break will be reduced to \$30 and should be paid by November 19. Payment for the week of Christmas Break will not be reduced and should be paid on December 17. *There will be no reduction of tuition for any other short weeks throughout the school year.*
- If a student only needs 1-3 days of care per week, they may pay the daily rate which is \$15 per day. The payment is expected on the day the student comes to ASC.
- Colts Camp ends at 6:00 PM each day. If a child is picked up late, there is \$1.00 per minute per child charge after 6:00 PM. The adult picking up the child will be notified of the number of minutes late and the student's After School Program account will be billed for late pick-up. If your bill isn't paid and you haven't spoken with Mr. Edwards about late payment, the ASC position can be forfeited.
- Payments can be paid by cash, check (written to CRES), or online through My School Bucks which can be found on the district webpage.
